4. Narrative: AT APPROXIMATELY 2330 HRS. 17DEC95 I RECEIVED A CALL FROM DEPUTY WALLACE WHO WAS WORKING THE COMPLAINT DESK AT STATION ONE. WALLACE INFORMED ME THAT DEPUTY DULAN WAS AT THE RESIDENCE OF TED KIMBLE ON BRANDON STATION COURT AND OUT WITH TED KIMBLE AND THOUGHT I SHOULD KNOW.

I CONTACTED SGT. LLOYD WHO WAS ALSO SUPPOSED TO BE INROUTE TO BRANDON STATION COURT BUT WAS DIVERTED TO ANOTHER CALL AND WAS IN ROUTE TO THAT CALL AFTER DEPUTY DULAN HAD GIVEN A SIGNAL 50. I ASKED SGT LLOYD TO HAVE DEPUTY DULAN CALL ME AT HOME AFTER HE CLEARED HIS CALL. I WANTED TO TALK TO THE DEPUTY THAT SPOKE WITH TED KIMBLE ON THE CALL.

DEPUTY DULAN DID NOT CALL, SO I CALLED COMMUNICATIONS AT 0500 HRS. AND HAD THEM CONTACT DULAN AND CONNECT HIM WITH ME.

DULAN SAID THAT THEY HAD A CALL BY A NEIGHBOR WHO SAW A VEHICLE AT THE KIMBLE RESIDENCE AROUND 2300 HRS. ON ARRIVAL HE FOUND A JEEP STATION WAGON IN THE DRIVEWAY AND RAN THE LICENSE PLATE WHICH CAME BACK TO TED KIMBLE. HE CHECKED THE HOUSE AND AREA AROUND THE HOUSE AND FOUND TED KIMBLE AND A WHITE FEMALE WALKING IN THE WOODED AREA BEHIND THE HOUSE AND TO THE RIGHT. DULAN STATED THAT TED KIMBLE TOLD HIM THAT HE WAS JUST CHECKING HIS PROPERTY AND THAT HE APPRECIATED HIM CHECKING THINGS OUT AND LOOKING AFTER HIS PROPERTY.
DULAN DESCRIBED THE WHITE FEMALE WITH HIM AS BEING SHORT, WITH SHORT BROWN HAIR AND BIG EYES.
DULAN ALSO SAID THAT THE JEEP WAS PULLED UP TO ABOUT 20 FEET FROM THE CARPORT OPENING AND WAS PARKED MOSTLY IN THE CENTER OF THE DRIVEWAY AND HAD THE LIGHTS ON.

At approximately 10:30 hrs. I received a call from Deputy Wallace who was working the complaint desk at station one. Wallace informed me that Deputy Dulan was at the residence of Ted Kimble at Brandon Station Court and out with Ted Kimble and thought I should

be taken to the deputy that spoke with Ted Kimble on the call. I wanted to have Deputy Dulan call me at home after he cleared his call. I asked not to call after Deputy Dulan had given a signal so I asked not to call to that station court but was diverted to another call and was in route to that station court. I was also supposed to be brought to Brandon

Deputy Dulan did not call, so I called competitors at 0800 hrs. and was then contact Dulan and correct him with me.

Dulan said that they had a call by a neighbor who saw a vehicle at the Kimble residence around 11:00 hrs. On arrival he found a Jeep station wagon in the driveway and saw the license plate which came back to Ted Kimble. He checked the house and area around the house and found Ted Kimble and a white female walking in the wooded area behind the house and to the right. Dulan stated that Ted Kimble told him that he was

checking his property and that he appreciated him checking things out. Dulan described the white female with him as being short, with short dark hair and blue eyes. Dulan also said that the Jeep was pulled up to about 20 feet from the front of the house and was parked mostly in the center of the driveway and the lights on.
