MY FATHER WILL SIGN ON MY BEHALF FOR WHAT HE RECEIVES AND EITHER COVER THE COST OF COPIES OR MAKE COPYS AND RETURN THE ORIGINALS AS EXPEDITIOUSLY AS POSSIBLE FOR YOU CONVENIENCE.

AT THE PRESENT TIME, THE FOLLOWING IS A LIST OF THE MATERIALS I AM ASKING YOU TO PROVIDE MY FATHER:

1. A COPY OF WARRENT - # 98 CRS 23399 [CONSPIRACY TO COMMIT SEXUAL ACTIVITY BY A CUSTODIAN];

2. ALL ORIGINAL LETTERS AND CARDS FROM MS. JANET SMITH, THAT I VOLUNTARILY RELINQUISHED TO YOU; YOU MAY RETAIN COPIES FOR YOUR RECORDS, IF YOU CHOOSE TO DO SO;
3. A COPY OF THE MEMORANDUM CIRCULATED BY JAMES CHURCH, AT THE DETENTION CENTER, DIRECTING CUSTODIAL OFFICES NOT TO TAKE ME OUT OF MY CELL WITHOUT (2) OFFICERS PRESENT;
4. COPIES OF DISCOVERY MATERIAL BY THE PROSECUTION, THAT ARE RELATED TO THE CONFISCATED LETTERS OF JANET SMITH AND I;
5. SPECIFIC DATE(S) OF ALL HEARINGS PRIOR TO TRIAL PROCEEDINGS.

AGAIN, I AM NOT TRYING TO INCONVENIENCE YOU OR MR. HATFIELD IN ANY WAY, BUT IT IS IMPORTANT THAT I RECEIVE THESE MATERIAL FOR MY OWN DOCUMENTATION. PLEASE LET ME ASSURE YOU, THAT MY EFFORTS TO ACQUIRE THE REQUESTED DOCUMENTS WILL IN NO WAY AFFECT YOUR ATTEMPTS TO EFFECTIVELY LITIGATE MY APPEAL, AND I AM CONFIDENT MY FATHER IS WILLING TO SCHEDULE A MEETING THAT IS MOST CONVENIENT FOR YOU AND/OR MR. HATFIELD.
