THE WHOLE THING WITH RONNIE KIMBLE STARTED WITH ME WHEN DETENTION OFFICERS TOLD ME AND OTHER INMATES THAT RONNIE KIMBLE WAS CAPABLE OF HURTING US AND TO WATCH OUR STEP. AFTER THAT STATEMENT TO US I BEGAN PAYING ATTENTION TO RONNIE TO SEE WHAT HE WOULD SAY OR DO. RONNIE WOULD INSTIGATE THINGS BY ONE MINUTE BE TALKING ABOUT GOD AND THE BIBLE AND THEN TURN AROUND THE NEXT MINUTE AND MAKE RACIAL REMARKS. I SAW RONNIE WITH A RAZOR KNIFE HE HAD MADE OUT OF A BATTERY. HE MADE THE KNIFE BY GRINDING THE METAL FROM THE BATTERY ON THE CEMENT FLOOR. RONNIE ALSO MADE A DEVICE TO SHOOT THE PINS THAT WERE IN THE BATTERIES. RONNIE MANUPLATES PEOPLE WITH HIS BIBLE TALK AND COVERS UP HOW HE REALLY IS. LIKE I SAID BEFORE HE WOULD BE TALKING ABOUT THE BIBLE AND JESUS CHRIST ONE MINUTE AND TALKING ABOUT INMATES THE NEXT MINUTE, MAKING COMMENTS ABOUT THEM AND MAKING RACIAL COMMENTS.

RONNIE ASKS OTHER INMATES ABOUT THEIR CASES AND WANTS TO TALK ABOUT THEM, BUT WHEN WE WOULD ASK ABOUT HIS CASE OR START TALKING ABOUT HIS CASE RONNIE WOULD SAY, THEY DON'T HAVE ANY EVIDENCE ON ME AND THEY ARN'T GOING TO GET ANY EVIDENCE ON ME. ONCE WHILE WE WERE TALKING RONNIE TOLD ME THAT HE HAD A SLEEPING DISORDER AND SAID HE DIDN'T KNOW WHAT HE MIGHT HAVE DONE IN THE MURDER CHARGE AGAINST HIM.

I DON'T THINK RONNIE WANTS ANYONE TO KNOW THE REAL RONNIE. HE TALKS ABOUT OTHER INMATES AND THEIR CASES BUT DON'T WANT ANYONE TO SAY ANYTHING ABOUT HIS CASE. EVERYONE IN THE CELL BLOCK WITH RONNIE THINKS OR HAVE BEEN TOLD BY OTHER INMATES THAT RONNIE HAS LEARNED ALL THESE KILLING TATICS AND ARE AFRAID OF HIM.

IF THINGS GO BAD FOR RONNIE AND OTHER INMATES, INCLUDING ME, RONNIE WILL TRY TO SMOOTH THINGS OVER WITH THE BIBLE AND GIVING CANTEEN ITEMS AWAY. RONNIE DOES THIS ESPECIALLY WHEN HE THINKS SOMEONE IS UPSET WITH HIM. HE HAS GIVEN A LOT OF CANTEEN ITEMS TO INMATES BECAUSE HE HAS DONE SOMETHING TO MAKE THEM UPSET WITH HIM OR HE IS TRYING TO COVER SOMETHING UP.

I DID SEE RONNIE KISSING THE FEMALE OFFICER AND SO DID OTHER INMATES. SHE WOULD COME UP ON THE FLOOR EARLY AND TAKE RONNIE OUT OF HIS CELL AND TO THE OFFICE AND THEY WOULD STAY FOR FIVE TO TEN MINUTES. I HEARD SHE HAD A CAMERA AND TOOK PICTURES OF RONNIE IN THE NUDE.

I HAVE HEARD RONNIE SAY IT WOULDN'T BE HARD TO ESCAPE FROM THIS JAIL.

HE SAID, "IT COULD BE DONE AND I COULD DO IT IF I WANTED TO". RONNIE TOLD ME THIS.

THERE WERE DETENTION OFFICERS THAT RONNIE HAD GOTTEN ON HIS SIDE, BLACK AND WHITE OFFICERS. I DON'T KNOW HOW HE DID IT WITH OTHER OFFICERS, OTHER THAN THE FEMALE OFFICER, BUT THEY COVER HIS BACK AND LOOK AFTER HIM.

RONNIE SAID HE WAS GOING TO SUE THE SHERIFF'S DEPARTMENT BECAUSE THE FEMALE OFFICER WAS SEXUALLY HARRASSING HIM. BUT I'LL TELL YOU RIGHT NOW THAT RONNIE KIMBLE WAS IN CONTROL OF THAT SITUATION WITH THE FEMALE OFFICER. HE TOLD ME ON ONE OCCASION THAT HE KNEW IT WAS WRONG, WHAT HE WAS DOING WITH THE FEMALE OFFICER, BUT THAT HE WAS THINKING WITH HIS DICK. ME AND OTHER INMATES TOLD RONNIE THAT HE SHOULD STOP THE THINGS WITH THE FEMALE OFFICER AND HE WOULD SAY, "I'M THINKING WITH MY DICK".

THE DAY BEFORE THEY GOT CAUGHT ANOTHER FEMALE OFFICER OPENED RONNIES CELL AND LET THE REGULAR FEMALE OFFICER IN RONNIES CELL WITH HIM. SHE STAYED IN RONNIES CELL FOR ABOUT FIVE TO TEN MINUTES. THIS WAS EARLY IN THE MORNING AS I RECALL. THE FEMALE OFFICER THAT LET HER IN RONNIES CELL WAS A SHORT, DARK COMPLECTED FEMALE FROM NEW YORK. I HAVE HEARD HER SAY THAT THIS JAIL ISN'T NOTHING, THAT SHE HAD PREVIOUSLY WORKED AT RIKERS ISLAND. OFFICER SLATE OR SLADE A BLACK MALE OFFICER WAS RONNIES MAN AND WOULD TAKE UP FOR RONNIE OVER OTHER INMATES. MAYBE OFFICER SLATE OR SLADE DIDN'T KNOW WHAT KIND OF A PERSON RONNIE REALLY IS. THERE WAS A INMATE NAMED JEFF WHO COMPLAINED ABOUT RONNIE AND GOT SHIPPED TO HIGH POINT. THE SGT. OR LT. CAME UP ON OUR FLOOR AND TOLD US THAT THE OFFICERS FLOOR AND THAT HE COULD RUN IT THE WAY HE WANTED TO AND HE DIDN'T WANT TO HEAR OUR COMPLAINTS. I DON'T KNOW THIS SGT. OR LT., BUT HE WAS SHORT AND WAS A WHITE MALE. I HAVN'T SEEN THE FEMALE OFFICER FROM NEW YORK SINCE RONNIE GOT CAUGHT.

AT ONE POINT I THOUGHT RONNIE WAS BEING SET-UP BY SOMEONE OR BY THE OFFICERS, BUT I CHANGED MY MIND WHEN I REALL SAW WHAT WAS GOING ON WITH RONNIE AND THE WAY HE DOES THINGS. THE THOUGHT ALSO CROSSED MY MIND THAT RONNIE WAS ACTUALLY GOING TO TRY TO ESCAPE FROM THE JAIL BECAUSE OF WHAT HE SAID ABOUT HOW HE COULD GET OUT OF THIS JAIL IF HE WANTED TO.

RONNIE IS JUST AS TWO FACED AS HE CAN BE. HE USES THE WORD OF GOT THE WRONG WAY. HE USES GODS WORD ON PEOPLE WHEN THEY ARE STRESSED OUT AND LATER WHEN THEY ARE THINKING RIGHT THEY GET UPSET AT RONNIE AND THATS WHEN HE TRYS TO SMOOTH THINGS OVER WITH THE CANTEEN ITEMS. RONNIE HAS GIVEN ME \$10.00 TO \$15.00 IN CANTEEN ITEMS BUT WHEN HE STARTED THE RACIAL SLURS I TURNED ON HIM BECAUSE I REALLY SAW WHAT KIND OF A PERSON HE WAS. I SPEAK TO RONNIE NOW, BUT WE DON'T CARRY ON CONVERSATIONS.

I KNOW THERE WAS THE TIME ME AND OTHER INMATES WERE AFRAID TO COMPLAIN ON RONNIE BECAUSE WE WERE AFRAID WE WOULD BE SENT TO THE HIGH POINT JAIL. AT ONE TIME I WOULD HAVE NEVER TOLD YOU ANYTHING ABOUT WHAT I HEARD RONNIE SAY OR WHAT HE SAID TO ME, BUT NOW I WILL BECAUSE I HAVE LEARNED WHAT KIND OF A PERSON HE IS. I DON'T KNOW IF HIS WIFE OR FAMILY KNOW WHAT KIND OF A PERSON HE REALLY IS AND IF THEY DON'T KNOW, THEY SHOULD.
