 ON 11/19/97 AT 0820 I WENT UP TO D FLOOR TO SEARCH INMATE KIMBLE'S CELL. WHEN  
 INMATE KIMBLE CAME OUT OF HIS CELL HE HAD 2 LEGAL PADS WITH HIM. I TOLD HIM TO  
 LEAVE THOSE NOTE PADS IN HIS CELL AND HE THEN TURNED AROUND AND ATTEMPTED TO TAKE  
 SOMETHING OUT OF HIS NOTE PAD. I THEN GRABBED HIM AROUND HIS WAIST AND TOOK HIM TO  
 THE BUNK. I THEN SAW INMATE KIMBLE ATTEMPTED TO PLACE THOSE PAPERS IN HIS MOUTH  
 THAT HE HAD TAKEN OUT OF HIS NOTE PAD. I THEN GRABBED THE PAPERS AND ATTEMPTED TO  
 TAKE THEM FROM INMATE KIMBLE'S MOUTH. THE PAPERS CAME OUT BECAUSE HE ONLY HAD SMALL  
 PIECE OF THE LETTER IN HIS MOUTH. I THEN INFORMED OFC. SOUTHERN TO CALL FOR LT.  
 BENNETT UP TO THE FLOOR AS WELL AS THE NURSE BECAUSE THERE WAS BLOOD COMING FROM INMATE  
 KIMBLE'S NOSE. CAPT. MONTGOMERY, LT. BENNETT AND MAJOR NESBIT REPORTED TO THE FLOOR
