

I RONNIE LEE KIMBLE WAS INCARCERATED IN THE GUILFORD COUNTY JAIL ON APRIL 1, 1997 IN GREENSBORO. AFTER BOOKING I WAS TAKEN TO D FLOOR WHICH IS SEGREGATION WHERE I WAS PLACED IN A SMALL SINGLE CELL AND STRIPPED OF MY CLOTHES AND LEFT WITH NOTHING BUT A BLANKET AND MATTRESS. WHEN I ASKED WHY I COULD NOT HAVE MY CLOTHES OR SHEETS I WAS TOLD THAT I WAS BEING PLACED ON SUICIDE WATCH. WHEN I ASK WHY THEY WOULD NOT GIVE ME AN ANSWER, THE CELL WAS EXTREMELY COLD AND FILTHY. I WAS LOCKED IN MY CELL 23 HOURS A DAY WITH NOTHING FOR A WEEK, I WAS PLACED ON ADMINISTRATIVE SEGREGATION AFTER SEEING THE PSYCHOLOGIST WHO RECOMMENDED THAT I BE TAKEN OFF SUICIDE WATCH.

ON OR ABOUT OCTOBER 8 1997 DEPUTY SHERIFF BISHOP CAME TO MY CELL LATE AT NIGHT AND HANDED ME AN ENVELOPE THAT WAS STAPLED TWICE. I THOUGHT IT MIGHT BE A LETTER FROM MY ATTORNEY BUT THOUGHT IT STRANGE SO I ASKED WHO IT WAS FROM. HE SAID YOU KNOW WHO IT'S FROM. I SAID NO I DON'T, HE SAID IT'S FROM JANET. I SAID WHO'S JANET. HE SAID THE LITTLE BLOND. I SAID WHO'S THAT. HE SAID MS. SMITH, I SAID OH, THAT WAS THE FIRST TIME I HAD HEARD DE. SMITH FIRST NAME. HE ASKED THAT I FLUSH THE LETTER WHEN I FINISH READING IT AND DISCOURAGE HER. INSTEAD I WROTE HER BACK ON THE BACK SIDE OF HER LETTER AND ASKED THAT SHE RETURN IT. I DID DISCOURAGE HER THOUGH BECAUSE I LOVED MY WIFE AND HAD NO INTEREST IN ANYONE ELSE.

8 OCTOBER 1997 LETTER - "1ST LETTER"

1ST PARAGRAPH AS YOU WILL SEE SHE CONTRADICTS DEPOSITION BECAUSE IT IS OBVIOUS BY WHAT SHE SAYS THAT THIS IS THE FIRST LETTER AND THAT SHE STARTED THIS.

2ND PARAGRAPH SHE SAYS THAT SHE WAS MY SOUNDING BOARD FOR MY FRUSTRATIONS, AND THAT SHE ENJOYED OUR MANY CONVERSATION. WE HAD ONLY SPOKE ON A FEW OCCATIONS. THE FIRST TIME SHE CAME TO MY CELL WALKED IN AND ASKED ME ABOUT MY FAMILY FLYING A BANNER AND RELEASING BADDONS ACROSS THE STREET. I ASK HOW SHE KNEW AND IF SHE SEE IT FROM HER FLOOR. SHE SAID NO THAT ANOTHER OFFICER TOLD HER. → D.S. McDANIEL. I TOLD HER WHAT MY WIFE

AND PARENTS DID, HOW MUCH I LOVED MY WIFE, (KIM) AND PARENTS RONNIE + EDNA KIMBLE, AND HOW I HAD BEEN FALSLY CHARGED.

I GOT A LITTLE TEARY EYES. \* ON ANOTHER OCCATION SHE CAME TO MY CELL LATE AT NIGHT WALKED IN AND ASKED ME HOW I WAS DOING. I THOUGHT IT TO BE REALY STRANGE AND I WAS FLOOR AS TO WHAT TO SAY. I TOLD HER I WAS FINE. I CAN REMEMBER MUCH MORE THAN THAT NOW. BUT THEN ABOUT 02:00 IN THE MORNING THE INMATE NEXT DOOR TO ME AND I WAS SEARCHED BY SGT. FAUCETT AND D.S. WHITE WHICH WAS VERY STRANGE BUT NOV. '85 19 WHEN SGT. FAUCETT CAME TO TAKE A STATEMENT FROM ME HE TOLD ME THEY HAD SEARCHED MY CELL BECAUSE SHE CAME BY.

ON INTO PARAGRAPH TWO SHE SAYS SHE'S BEEN BAND FROM D FLOOR AND SHE'S UNDER CLOSE SERVALENCE. IF THEY SUSPECTED HER OF HAVING RELATTIONS WITH ME BEFORE SHE HAD EVER



WRITTEN ME THIS LETTER THEN WHY DID THEY PUT HER BACK  
ON MY FLOOR LATER?! THIS SHOWS THAT THEY INTENTIONAL  
INCOURAGE THIS!
