Dear Ted:

I regret to inform you that on April 5, 2001, the State Supreme Court denied the petition for discretionary review in your case. That means the Court has decided *not* to review the Court of Appeals' opinion which upheld your sentences. As you know, the Office of the Appellate Defender was appointed to represent you on appeal. Unfortunately, the appeals process is now over and there is nothing more my office can do for you. Therefore, our legal representation of you has come to an end.

You should know that you yourself have the right to file a petition for writ of certiorari in the United States Supreme Court to "appeal" the State court decisions. Such a petition must be filed by July 4, 2001. You also have the right to file a post-conviction petition for writ of habeas corpus in United States District Court alleging any violations of your federal constitutional rights I argued in your brief. Such a petition must be filed by April 5, 2002.

Finally, you have the right to file a post-conviction motion for appropriate relief ("MAR") in Guilford County Superior Court alleging errors that I could not argue in your brief, such as newly discovered evidence or ineffective assistance of counsel. A group of lawyers in Raleigh will study your case for free and might decide to take it into post-conviction. You can contact them at the following address:
