4. Narrative: WENT INTO THE HOUSE WITH TED ON WEDNESDAY THE 11TH. TED LOOKED AROUND AND SAID THAT HE THOUGHT SOME VIDEO TAPES AND CD'S WERE MISSING, SAID THAT THE VCR WAS AT THE APARTMENT COMPLEX.

STOOD IN THE KITCHEN IN FRONT OF THE MICROWAVE AND DID CRY BRIEFLY, ABOUT 10 SECONDS AND SAID THAT HE HAD GIVEN THE PANTRY CABINET THE MICROWAVE WAS IN TO HER FOR HER BIRTHDAY IN SEPTEMBER AND HAD JUST BEEN INSTALLED LAST WEEK. A

WENT TO THE OTHER END OF THE HOUSE AND WENT TO FRONT BEDROOM FIRST AND LOOKED AT HIS THINGS--DESK TOOLBOX ETC. THEN WENT TO MASTERBEDROOM AND SAID DID THE FIREMEN DO THIS AND TOLD ME THAT THE GLOCK PISTOL WAS UNDER THE BED NEXT TO THE OUTSIDE END WALL. B SAID THE TRAY TO THE JEWELRY BOX WAS MISSING AND THERE WAS THREE BRACELETS AND 4 OR 5 NECLACES IN THE TRAY. SAID THAT HE DID NOT SEE ANYTHING ELSE MISSING. DID SAY THE REMINGTON .45 AMMO WAS IN THE WRONG ROOM THAT IT WAS SUPPOSED TO BE UNDER HIS BED WITH THE PISTOL. C

NEVER ONCE DID HE ASK ANYTHING ABOUT HIS WIFE. I ASKED HIM WHAT WAS LOST THAT MENT THE MOST TO HIM AND HE SAID IN A LOW VOICE, MY WIFE. TED WAS GEATHERING UP PICTURES THROUGHOUT THE HOUSE AND AFTER WE WENT C WE TURNED THE HOUSE OVER TO HIM AND HE AND HIS PARTENTS GOT AS MANY PCTURES AS THEY COULD, TED HANDED THEM OUT THE WINDOW.

WHILE HANDING PICTURES OUT THE WINDOW INSPECTOR RICH WAS PRESENT AND HEARD HIS MOTHER SAY THAT PATRICIA LIKED TO TAKE PICTURES AND TED FROM INSIDE THE HOUSE SAID MOTHER TWO OF US LIKED TO TAKE PICTURES, BUT ONLY ONE LIKED TO PAY FOR THEM. D RELATED TO WHEN WE LOOKED IN PATRICIAS CAR AND THERE WERE BLURRED PICTURES AND TED TOLD ME THAT PATRICIA WOULD SAVE THEM AND TAKE THEM BACK AND GET CREDIT FOR THEM.
