Narrative: TED KIMBLE PAGED ME TODAY AND I CALLED HIM AND HE ASKED IF I WAS COMMING BY HIS PLACE OF BUSINESS TO SHOW HIM THE PICTURE THAT HE WAS GOING TO BE IN AND OUT AND THAT HE NEEDED TO KNOW IF I WAS COMMING BY. I TOLD HIM YES AND HE WANTED TO KNOW HOW LONG AND I TOLD HIM THAT I COULD BE THERE BY 1430 HRS. I WENT BY MY OFFICE AND PICKED UP A PHOTO THAT I HAD FOUND IN HIS HOUSE TO SHOW HIM FOR ID AND DROVE ON TO HIS BUSINESS. (A)

WHEN I ARRIVED I PARKED AND WENT IN THE OFFICE AND THERE WAS A YOUNG LADY IN THE OFFICE WITH HIM WHO HE INTRODUCED TO ME AS VALLEY BLAKLEY. VALLEY IS JANET BLAKLEYS SISTER AND IS CURRENTLY ENROLLED AT SOUTHEAST HIGH SCHOOL. (B)

BOTH TED AND VALLEY WERE IN A VERY GOOD MOOD AND SMILEING AND TED SEEMED VERY HAPPY AND JOYFUL AND SHOWED ME A PICTURE OF HIMSELF AND ALL OF A PARTY OF CHURCH YOUNG PEOPLE AND DESCRIBED THE THREE ON THE PICTURE THAT HE HAD DATED AND SAID ALL HE HAD DATED, MEANING FOR THE PAST SEVERAL YEARS. THE THREE WERE JANET BLAKLEY, KIM PALMER AND PATRICIA BLAKLEY. I HAVE SPOKEN TO KIM PALMER AND JANET BLAKLEY, BOTH GAVE ME STATEMENTS ABOUT TED AND THEIR ASSOCIATION WITH HIM.

I SHOWED TED THE PHOTO I HAD AND HE MADE ID ON THE PERSON AS BEING ONE OF THE PEOPLE IN HIS CHURCH AND AS BEING AN OLD PICTURE.

I DID NOT ASK ANY QUESTIONS DUE TO THE FACT THAT VALLEY BLAKLEY WAS PRESENT AND I DIDN'T HAVE A CLUE WHY SHE WAS THERE DUE TO THE INFORMATION THAT HER SISTER HAD GIVEN ME DURING OUR INTERVIEW. I LEFT AFTER ABOUT TEN MINUTES. (C)

He is a very good looking and smiling and he seemed happy and joyful and showed me a picture of himself and all of a group of young people and described the scene on the picture that I had taken and said all had dated, meaning for the past several years. The three were Janet Stanley, Kim Palmer and Patricia Stanley. They were all in the picture and Janet Stanley both gave me statements and their association with him. I had the photo I had and he made ID on the person as being one of the people in his church and as being an old picture. I did not ask any questions due to the fact that Vally Stanley was a friend and I didn't have a clue why she was there due to the information that her sister had given me during our interview. I left the office in 10 minutes.
