- 1. Narrative: THE FOLLOWING IS A LIST OF SOME OF THE STATEMENTS MADE TO ME BY TED KIMBLE THAT ARE NOT TRUE. I THOUGHT IT NECESSARY TO MAKE THIS ENTRY AT THIS TIME DUE TO THE FACT THAT TED AND HIS MOTHER ACCUSED ME OF TRYING TO SLANDER TED AND HIS GOOD NAME.

ON THE NIGHT OF 09OCT95 TED TOLD ME THAT HE HAD THREE GUNS IN HIS HOUSE. ON FURTHER INVESTIGATION AND TED TELLING ME AGAIN ON 10OCT95 THAT HE INFACT DID NOT HAVE THREE GUNS IN THE HOUSE ONLY ONE, A .45 CAL. GLOCK PISTOL. THE 1100 REMINGTON SHOTGUN WAS AT HIS BUSINESS, HE HAD TAKEN IT THERE TO CLEAN IT. THE 300 WIN.MAG. DID NOT EXIST, TED DOES NOT OWN DNE. THE .45CAL GLOCK PISTOL WAS IN THE HOUSE.

HE TOLD ME THAT HE HAD CANCELLED THE \$200,000.00 LIFE INSURACE POLICY AFTER FINDING PATRICIA UPSET ABOUT IT. HE HAD NOT.

HE TOLD ME THAT PATRICIA HAD BEEN CURSED OUT AT WORK AND WAS UPSET AND CRYING AND THATS WHY HE FORGED HER NAME. I CONTACTED EMPLOYEES AT CINNAMON RIDGE, BILL HAWKINS AND NANCY YOUNG AND ASKED THEM IF THEY OF ANYONE THAT HAD CURSED PATRICIA APPROXIMATELY TWO WEEKS BEFORE DEATH AND UPSET HER AND BOTH SAID THEY KNEW OF NO INCIDENT OF ANY SUCH ACTION AND THAT THEY WOULD HAVE KNOWN BECAUSE PATRICIA WOULD HAVE COLD THEM AND BILL HAWKINS SAID HE WOULD NOT LET ANYONE TALK TO HER THAT WAY.

HE TOLD ME THAT VALLEY BLAKLEY HAD COME BY TO SEE HIM BECAUSE SHE WAS TAKING IT HARD ABOUT HER BOYFRIEND BEING KILLED IN AN AUTO ACCIDENT JUST DAYS BEFORE PATRICIAS DEATH. IN FACT I TALKED TO VALLEY AND SHE TOLD ME THAT TED HAD CALLED HER HOUSE AND HAD ASKED TO SPEAK WITH HER AND SHE WAS NOT THERE AND THAT SHE HAD WENT BY TO SEE WHAT TED WANTED, NOT BECAUSE OF HER BOYFRIENDS DEATH.

HE SAID THAT GETTING ADDITIONAL INSURANCE WAS A MUTUAL AGREEMENT BETWEEN IM AND PATRICIA AND ON INVESTIGATION I FOUND THAT PATRICIA HAD TOLD HER ROTHER RUEBEN THAT THEY HAD ENOUGH INSURANCE AND DIDN'T WANT ANYMORE. HE HAD ALSO TOLD HER FRIENDS THAT IF SHE DIED THAT TED WOULD BE WELL 'ROVIDED FOR AND NOT OWE ANYTHING AND HAVE SEVERAL THOUSAND DOLLARS LEFT OVER.

HERE IS A DIFFERANCE AS TO HOW TED GOT THE APPLICATION TO THE 200,000.00 LIFE INSURANCE POLICY AND HOW IT WAS HANDLED. MR JARRELL, HE AGENT, SAID HE TOOK THE APPLICATION BY AND THAT TED WENT IN THE UILDING AND BROUGHT IT BACK SIGNED AND THEN WENT TO ANOTHER BUILDING

AND GOT THE CASH MONEY AND PAID HIM IN CASH. TED SAID HE TOOK THE APPLICATION HOME AND THATS WHEN PATRICIA WAS UPSET AND CRYING AND HE SIGNED HER NAME TO THE APPLICATION.
