A. I would remember that I met with Sherri Wilson
 at the Waco Police Dept for the purpose of discussing
 concerning my knowledge of the night time of activity
 around the Waco Police Dept before her death.
 It was stated that she was a student at the

University of North Carolina at Greensboro, a sophomore music major. I asked if she knew Kimberly and Ronnie Kimble and she stated that she did know them and stayed with Kimberly at their mobile home during the week at this time.

She also said that she attended Monett Rd. Baptist Church and had known Ronnie Kimble for several years and thought a lot of both Ronnie and Kimberly. Sherry said she had been introduced to Ronnie's friends that he brought home on weekends from Camp Lejeune. At present she is dating James Allen Dziadaszek a marine and friend of Ronnie Kimble. She has been seeing him for two months now, and she rode with Kimberly to Camp Lejeune this past weekend to see Dziadaszek. I asked her if she knew Justin Dobsch, another marine friend of Ronnie's and she said that she did and in fact dated him ~~four~~ (4) times back in 1995. She stopped seeing him because, in her words, "he wanted someone who would put out and I don't do that", so she stopped seeing him. She went on to say that ^{at the time} ~~after~~ she was seeing Dobsch

was before Patricia Kimbles death. I asked her if she remembered seeing him on a weekend and on a Sunday when they attended church together. She remembered him attending church with her at Monnett Road Baptist Church and said she thought it was the Sunday after Labor Day in 1995 and that she saw him one time after that. If Dobersch came back home with Ronnie after that she has no knowledge of same.

She said that on the Monday night that Patricia was killed that she was in a concert where she played the tuba and her parents were in the audience. After the concert and at home her parents were notified by church members of the fire and that Patricia might be dead.

Sherry also stated that her father Homer Wilson was a Deacon in Rev. Kimbles church and very good friends of the Kimbles.

Sherry ended up the interview saying that she didn't think Ronnie would have ever had any thing to do with Patricia's death and if she learned anything that might help me in the case that she would call me.
